Terms and Conditions of Membership of Paddle New South Wales Incorporated

In applying and in consideration of my application for membership being accepted I **acknowledge and agree** that:

1. **"PNSWI"** for the purposes of this membership application and declaration means and includes Paddle New South Wales Incorporated, its members (including Affiliated Clubs) and where the context so permits, their respective directors, officers, members, servants or agents.
2. **If accepted I will be a member** of PNSWI.
3. **This document cannot be amended.** If amended or altered in any way, my application will be null and void.
4. **The PNSWI Constitution** is a contract between me and PNSWI. I acknowledge and agree to comply with the Constitutions and By-Laws of PNSWI.
5. **Insurance** is in place that provides limited cover to me whilst I am performing or participating in any authorised or recognised PNSWI activity ("**PNSWI Activity**").  - (a) I release and forever discharge PNSWI from all Claims that I may have or may have had but for this release arising from or in connection with my membership and/or participation in any PNSWI Activity; and

9. **Fitness to Participate:** I declare that I am and must continue to be medically and physically fit and able to participate in any PNSWI Activity. I am not and must not be a danger to myself or to the health and safety of others. I will immediately notify PNSWI in writing of any change to my fitness and ability to participate. I understand and accept that PNSWI will continue to rely upon this declaration as evidence of my fitness and ability to participate.
10. **I have provided the information required** and I warrant that all information provided is true and correct.
11. **Privacy:** I understand that the information I have provided elsewhere in the membership application is necessary for the Objects of PNSWI.
